**Object:** Request for Expressions of Interest for **SELECTION OF CONSULTANTS (LEGAL ENTITY), BY WORLD BANK BORROWER FOR THE STATE SECRETARIAT OF ADMINISTRATION AND HUMAN RESOURCES, ENVISAGING THE DEVELOPMENT OF AN INFORMATION SYSTEM (PROCUREMENT MANAGEMENT SYSTEM) THAT FULFILS THE REQUIREMENTS OF MODERNIZATION, CENTRALIZATION, STANDARDIZATION AND CONTROL OF THE PROCEDURES REQUIRED TO THE COMPETENT PROCUREMENT PROCESS.**

1. Rio Grande do Sul State Government, due to a loan from the International Bank for Reconstruction and Development (hereinafter "World Bank") to cooperate in the execution of the Swap to Strengthen Public Investment Project (*Programa de Apoio à Retomada do Desenvolvimento Econômico e Social do Rio Grande do Sul – PROREDES BIRD*), intends to use part of such loan for payment of consultant services, in accordance with the Selection and Employment of Consultants by World Bank Borrowers.

2. We invite firms interested in providing consultant services to send a letter of Expression of Interest, exclusively to the Special Bidding Committee (*Comissão Especial de Licitações – CEL PROREDES-BIRD/RS*) (address below), **by Nov/09/2012**, appending its "PORTFOLIO" and the documents evidencing experience in the carrying out of similar works, in accordance with paragraph 5, below.

3. The firm will be selected by **Quality and Cost Based Selection – QCBS**, in accordance with the "Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits by World Bank Borrowers" dated January 2011.

4. This hiring aims at providing consultant services for the:

- a) **Development of a solution for the Procurement Management System;**
- b) **Integration with the State Corporate Systems;**
- c) **Migration of data from the Bidding System currently used to the new Procurement Management System;**
- d) **Installation of the system in the operational environment of the State Data Processing Company (*Cia. de Processamento de Dados do Estado do Rio Grande do Sul – PROCERGS*), the company that provides information services for the State Central Procurement Agency (*Central de Compras do Estado*);**
- e) **Training;**
- f) **Implementation for Direct Administration, Foundations and Autonomous Public Institutions of Rio Grande do Sul State;**
- g) **License to use the Procurement Management System in a definite way, as well as other software products and components that integrate the solution;**

- h) Technical and operational documents of the system;**
- i) Technical support and maintenance;**
- i) Transfer of technology and of tools used for developing the Procurement Management System; and**
- j) Provisions for the possibility of implantation in the Semi-State Companies, Public Companies and entities of other State Branches of Rio Grande do Sul.**

5. The expression of interest must contain at least the following information:

- a) Prospectus presenting the Consulting firm;**
- b) List of firms/institutions benefited by similar works already developed and concluded, preferably public entities;**
- c) Name, telephone and contact e-mail of the person in charge of managing these firms/institutions benefited by similar works;**
- d) Description of similar works developed and concluded, with the conclusion date;**
- e) Terms of the three last signed and concluded contracts, whose object is similar to the required services.**
